"Hockey Night @ Timothy's Restaurant" will take place on Saturday night beginning at 8:00pm.



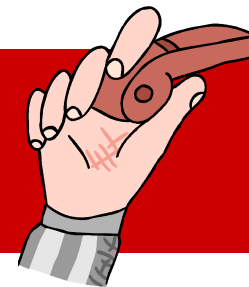
